Why an Endowment Trust ?

The Endowment Trust, which was established in 2014, will help secure the financial future of our Church in good times and bad.

How will the Endowment Trust do that?

The cost of the wide range of services which St Aidan's provides to the community keeps increasing. Funds received by the Endowment Trust will be secured and invested for the future and the income from those funds will help offset the increased demands on the Church's financial resources.

Who will manage the funds ?

The Trustee is The General Trust Board of the Anglican Diocese of Auckland who will manage the secure investment of the capital fund and the distribution of the income.

What has been received so far?

The Endowment Trust has over \$100,000 in capital funds already.
