Note to the financial statements

for the year ended 31 December 2022

Reporting Entity

The financial statements are in respect of St Aidan's Endowment Trust. The trustee is the General Trust Board of the Diocese of Auckland.

St Aidan's Endowment Trust has been established to provide financial support for the Anglican Parish of St Aidan's, Remuera.

Measurement base

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on an historical cost basis are followed by the Trust, with the exception that investments are re-valued.

The Trustees have approved the accounting policies adopted and the disclosures made in these financial statements.

Specific Accounting Policies

Investments

Investments have been recorded at market value at balance date. Unrealised gains and losses on investments are recorded in the Statement of Financial Performance.

Income on investments

Income from the Balanced Fund is recorded on the basis of taxable income as declared by the fund.

Income tax

The Trust is exempt from Income Tax on the basis of its charitable purpose. The Trust is registered with the Department of Internal Affairs Charities. The registration number is CC51585.

Goods and services tax

The entity is not registered for GST purposes and therefore the financial statements have been prepared on a GST inclusive basis.

Changes in accounting policies

The accounting policies adopted are consistent with those adopted in the previous year.
